The focus of this course is to provide the training required by the State and Baltimore County as a pre-requisite for the Journey and/or Master Natural Gas Fitter examination. This course covers the installation, operation and maintenance of gas piping, 2lb systems and gas equipment. *Book used in this course is the 2012 National Fuel Gas Code.*

**NOTE:** Applicants may wish to take this course for Code review purposes only.

**Requirements:** An individual enrolled in this program may not miss more than three (3) hours of classroom activities in order to receive credit for the course, he/she may not miss venting or the 2 lb gas portion of the class. **OPTIONAL:** As a pre requisite for the State Natural Gas Fitters Examination certain applicants are required to successfully complete and pass an approved 24 hour Natural Gas Fitters Training Course, which includes both a written and hands on test. As a State of Maryland approved provider of Gas Fitters Training we offer this test at the completion of the course. **NOTE:** The test is not mandatory for all attendees.
